

# Confidentiality Policy of «AstanaFinanceDays» mobile application

---

This Confidentiality Policy of the AstanaFinanceDays mobile application (**Policy**) applies to all information that Astana International Financial Centre Authority (**AIFC Authority**) receives about the user during his use of this application.

The use of “AstanaFinanceDays” mobile application (**Application**) means the unconditional consent of the user to this Policy and to the conditions for processing his personal data specified therein; in case of disagreement with these conditions, the user should refrain from using the application.

## 1. Personal data of users that is received and processed by the “AstanaFinanceDays” application

1.1. As part of this Policy, “user’s personal data” means:

1.1.1. Personal data that the user provides about himself when registering (creating an account) or when using the Application. Information is provided by the user at his own discretion.

1.1.2 Data that is automatically transmitted to the AIFC Authority in the process of using the Application, including information about the user's device.

1.2. This Policy applies only to the “AstanaFinanceDays” application by the AIFC Authority. The AIFC Authority does not control and is not responsible for the information of the third parties available through the links posted on the application. On such websites, other personal data may be collected or requested from the user, and other actions may be taken.

## 2. Purpose of the collection and processing of the user’s personal data

2.1. The application collects and stores personal data that is necessary for the provision of services included in the application.

2.2. The Application user’s personal data can be used for the following purposes:

2.2.1. Identification of the parties under the agreements;

2.2.2. Providing the user with personalized services;

2.2.3. Communication with the user, which includes sending of notifications, requests and information regarding the use of services, provision of services, as well as processing requests and requests from the user;

2.2.4. Improving the quality of the Application, its ease of use, and development of new services;

2.2.5. Conducting statistical and other studies based on the data collected.

### 3. Conditions for processing personal data of the user and its transfer to third parties

3.1. The application stores the user's personal data in accordance with the regulations of the AIFC Authority.

3.2. With respect to the user's personal data, confidentiality is maintained, except in cases where the user voluntarily provides information about himself/herself to the general public.

3.3. AIFC Authority is entitled to transfer the user's personal data to third parties in the following cases:

3.3.1. The user has consented to such actions;

3.3.2. The transfer is necessary for the user to use a particular service

3.3.3. The transfer is stipulated by the current law of the Astana International Financial Centre (**the AIFC law in force**) under the procedure established by law;

3.4. When processing the Application user's personal data, the AIFC Authority is guided by the current AIFC law.

### 4. Change of the user's personal data

4.1. The user can change or add personal data by contacting the specialists of the AIFC.

4.2. The user can also delete the personal data provided within a certain account by requesting the removal of his account through the specialists of the AIFC Authority via email [info@aifc.kz](mailto:info@aifc.kz).

## 5. Measures used to protect personal data of users

The administration of the AIFC takes the necessary and sufficient organizational and technical measures to protect the user's personal data from illegal or accidental access, destruction, alteration, blocking, copying, distribution, and also from other illegal actions that involve the third parties.

## 6. Changes to the Confidentiality Policy. Applicable law:

6.1. AIFC Authority has the right to make changes to this Confidentiality Policy. When making changes in the current edition, the date of the last update is indicated. The new version of the Policy comes into force from the moment of its publication, unless otherwise provided by the new version of the Policy. 6.2. This Policy and the relationship between the user and the AIFC Authority is subject to the current law of the AIFC.
